Dear Antonio,

I hope this email find you well!

I wanted to get your views on idea we are pursuing.

[REDACTED], [REDACTED] Microsoft, will be in town on **15<sup>th</sup> February**. We have a public event in our Center in the morning on hybrid threats in cyber and [REDACTED] will then be invited by the European Political Strategy Center in the Berlaymont to give a lunch talk on AI and its impact on society (from 1pm to 2pm) in the Berlaymont.

Thereafter, we are thinking that a small roundtable with heads of cabinets could be of mutual benefit. This would allow us to raise the pressing topics on AI directly with [REDACTED] in a small group (maybe also in the context of other topics such as illegal content) and more generally how to foster AI in Europe. I shared the idea with [REDACTED], she did like it, and also reached out informally to [REDACTED].

Please let me know if you would be interested in such an approach and whether you are in town (it is unfortunately a school holiday). If a meeting could take place directly after the lunch discussion on AI (**3pm to 4pm**) that would be the ideal.
