The Company Due Diligence Questionnaire was filled in for a company that does not act as the bidder. Only on demand the Company Due Diligence Questionnaire was handed in later for the bidding company on 2 March 2016. The information provided in the Company Due Diligence Questionnaire from 2 March 2016 concerning the shareholder structure does not match the information found in open sources. We judge these two facts as highly critical (red flag). In addition, some further information such as the date of incorporation or the key individuals of the company given in the Due Diligence Questionnaire from 2 March 2016 could not be confirmed through research of available online sources.
