Cooperation with eu-LISA

- FRA contributed with a fundamental rights training module in the ETIAS Essentials on-line course for eu-LISA technical staff. (May 2021)
- FRA will contribute with a fundamental rights training module in the EES Essential on-line course for eu-LISA technical staff (September 2021).
- FRA had an exchange with eu-LISA colleagues on the work on artificial intelligence at working level.

Cooperation with CEPOL

- FRA -CEPOL webinar on data subjects rights in the EU IT systems, together with the Chair of the Coordinated Supervision Committee (Portuguese DPA)- (10 May)
- FRA is contributing to the set-up of a training curriculum on the EU IT systems and interoperability within CEPOL Knowledge Centre on Law Enforcement Cooperation, Information Exchange and Interoperability. (several meetings)

Cooperation with Frontex

- FRA carries out a fundamental rights modules in the Frontex Entry and Exit residential training, that are carried on a quarterly basis.
- In the framework of the Innovation Hub, FRA provides fundamental rights expertise in two migration related projects:
- Frontex Technology Foresight Experts' Consultation on Biometrics for the Future of Travel a research study on the impact of emerging biometric technologies that could be deployed at the border crossing at the EU external borders.
- Frontex pilot project on Entry- Exit system

Cooperation with Europol

- FRA Director and Europol ED met on 21 April 2021 to discuss possibilities for further enhancing cooperation
- FRA Director will meet Europol ED, heads of operational centres and of the innovation lab during his visit on 24 June 2021
- MoU between Europol and FRA will be signed in The Hague on 24 June 2021 and a list of concrete joint activities agreed
- FRA has been attending the fortnightly meetings of the virtual Team of the Innovation Hub for Internal Security chaired by Europol
- FRA is supporting Europol's Hub project "Accountability principles for AI", co-chairing a workshop with civil society and other fundamental rights experts on 2 June
- FRA is going to contribute to briefing of Europol guest officers posed in Greece about fundamental rights aspects of their work at external borders
- FRA Director is invited to attend as a keynote speaker Europol's Data Protection Experts Network (EDEN) Conference in Rome in October 2021

Cooperation with Eurojust

- FRA Director and Eurojust President will be meeting in The Hague on 24 June 2021 to explore possibilities for further cooperation
- FRA is supporting the Eurojust-led activity under the EU Victims' Rights Strategy to look at possibilities to facilitate cross-border cooperation between national authorities
