The incident involves allegations on so called "pushback" of 2 persons by the Hellenic police to the border with Turkey without taking into consideration their personal circumstances. Such police action may amount to collective expulsion, which Article 19 of the EU Charter explicitly prohibits. Furthermore, in the course of aforementioned police actions, it is clear that the persons subjected to these actions did not have access to an effective remedy when transferred to the border with Turkey. In this context, Text Removed - Human Resources would like also to underline the importance of conducting an efficient investigation in incidents involving violations of fundamental rights of such nature.
Final outcome	Please refer to the Fundamental Rights Officer Final Report. Taking into consideration the increased number of reports from different sources and testimonies, there is reason to ask the Hellenic authorities for examining whether such practices exist in a more comprehensive manner. Text Removed - Human Resources recommends that the investigative procedure should be conducted in full compliance with the principles of impartiality, objectivity and confidentiality. A second body was found on Sunday morning at the same beach and the third corpse was discovered on Sunday at Text Removed - Operational Area.
