We refer to your e-mail of 23 February 2022, registered on 24 February 2022, in which you make a request for access to documents under the above-mentioned reference number, following the documentation first provided by the Directorate-General for Internal Market, Industry, Entrepreneurship and SMEs (DG GROW) under GESTDEM 2021/8086.

1. SCOPE OF YOUR APPLICATION

By your application, you request access to the following correspondence from the list we provided under GESTDEM 2021/8086:

2. DOCUMENTS FALLING WITHIN THE SCOPE OF THE REQUEST

We have identified the enclosed documents falling in the scope of your request:

- The document compiling 15 pieces of correspondence and related position papers with business stakeholders (<u>Document 1</u>).
- The document compiling 4 minutes falling under the scope of your initial request which could not be granted access previously under GESTDEM 2021/8086 as we had to receive the agreement on disclosure of the consulted stakeholders (Document 2).

3. ASSESSMENT UNDER REGULATION 1049/2001

Following an examination of the identified documents under the provisions of Regulation 1049/2001 we have arrived at the conclusion that access can be partially given to Document 1 and Document 2.

In particular, partial disclosure of Document 1 and Document 2 is prevented by exceptions to the right of access laid down in Article 4 of Regulation 1049/2001.

Parts of the identified document are covered by the exception concerning the protection of privacy and integrity of the individual outlined in Article 4(1)(b) Regulation 1049/2001, since they contain the following personal data:

- the names/initials, functions and contact information of Commission staff members not pertaining to the senior management;
- Names, functions and contact information of other natural persons.

Article 9(1)(b) of the Data Protection Regulation¹ does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Therefore, I conclude that, pursuant to Article 4(1)(b) Regulation 1049/2001, access cannot be granted to the personal data contained in the requested document, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

Consequently, personal data is redacted in Document 1 and Document 2.

In addition, the position papers corresponding to n. 22, 26 and 27 are publicly available. For ease of reference, they are also included in Document 1.

Furthermore, following our reply of 23 February 2022 to your request under GESTDEM 2021/8086, please note that 4 additional minutes falling under the scope of your request can be granted access, in accordance with our examination under Regulation 1049/2001 and taking into account the positions of the consulted stakeholders.

- 3) Minutes 08/09/2021 Zalando
- 4) Minutes 09/09/2021 Rehau

These 4 additional minutes are compiled in the attached Document 2.

Please also note that the final decision from a third-party under GETDEM 2021/8086 is still pending for the following minutes: Minutes 01/07/2021 - unilever. We apologize for this additional delay and will send you the final response as soon as the third-party has come back.
