

Subject: Your request for access to documents - GestDem 2022//8086



We refer to your e-mail of 23 February 2022, registered on 24 February 2022, in which you request access to documents under the above-mentioned reference number, following the documentation first provided by the Directorate-General for Internal Market, Industry, Entrepreneurship and SMEs (DG GROW) under GESTDEM 2021/8086.

As we stated in our reply of 21 March 2022, concerning one document containing *minutes* 01/07/2021, the relevant stakeholder was consulted under Regulation 1049/2001. The stakeholder has agreed to grant access to the minutes – enclosed as **Document 1**.

Protection of privacy and integrity of individuals

Parts of Document 1 is covered by the exception concerning the protection of privacy and integrity of the individual outlined in Article 4(1)(b) Regulation 1049/2001, it contains the following personal data:

- the names/initials and contact information of Commission staff members not pertaining to the senior management;
- Names, functions and contact information of other natural persons.

Article 9(1)(b) of the Data Protection Regulation¹ does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Therefore, I conclude that, pursuant to Article 4(1)(b) Regulation 1049/2001, access cannot be granted to the personal data contained in the requested document, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

Consequently, personal data is redacted in the identified document.

Reuse of documents

The minutes were drawn up for internal use under the responsibility of the relevant services of the Directorate-General for Internal Market, Industry, Entrepreneurship and SMEs (DG GROW). They solely reflect the services' interpretation of the interventions made and do not set out any official position of the third parties to which the documents refer, which were not consulted on the contents. They do not reflect the position of the Commission and cannot be quoted as such.

Means of redress:

In accordance with Article 7(2) of Regulation (EC) No 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.
